

THE PRIVACY POLICY OF THIS SITE - BECAUSE THIS NOTICE

This page describes how to manage the site in relation to the processing of personal data of the same navigation. This notice is made to art. 13 D. Lgs. No 196/2003 (**Law Italian Privacy**) to those who interact with the services of our website, accessible electronically. This notice only for our site, and not to other web sites visited by using links. • PLACE FOR TREATMENT OF DATA AND PURPOSE

The treatments related to the services on this web site are at the aforementioned office only by staff in charge of treatment, or any occasional maintenance. No data deriving from the web is communicated (unless prior consent of affected) or widespread. The personal data provided by users who request information material through enrollment in the section (newsletters, promotions, relationships, initiatives, communications, acts and measures, etc.). They are used for the sole purpose of running the service or the request and are not disclosed to third parties, except in cases where it is requested and obtained the express consent or disseminated in any case.

• TYPES OF DATA TREATIES

Data Navigation

The systems and software procedures for the operation of this site acquired in the ordinary course of operations, personal data transmission which is implicit in the communication protocols of the Internet. This information is not collected to be associated with the identified, but by their very nature could, through processing and association with data held by a third party, allowing users to identify. This category includes IP addresses or domain names of the computers used by users to connect to the site, the URI (Uniform Resource Identifier) of the resources required, the time of the request, the method used to submit the request to the server, the file size obtained in response, the numerical code indicating the status of the response from the server (successful, error, etc.), and other parameters relating to the operating system and the information used by the user. These data are used, where applicable, for the sole purpose of obtaining anonymous statistical information about the site and to verify the proper operation and will be deleted immediately after processing. The data could be used for the determination of liability in the event of hypothetical crimes against the site.

Sending optional, voluntary and express mail to the addresses indicated in this site involves the acquisition of the sender's address, which is necessary to respond to requests, as well as any other personal data included in the mail. • COOKIES

No personal user data is intentionally acquired from the site. It is not made use of cookies for the transmission of information of a personal nature, nor are used c.d. Persistent cookies of any kind, or systems for tracking users. Using c.d. Session cookies (which are not stored on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) to allow safe and exploration efficient site. The c.d. Session cookies used in this site avoid the use of other technical information potentially damaging to the confidentiality of navigation for users and do not allow the acquisition of personal identification data.

• OPTIONAL CONFIRMATION OF DATA

Under the same Article shall have the right to request cancellation, the transformation anonymously or block of data processed in violation of the law, and oppose any case, for legitimate reasons, to their treatment.
